Dear Speaker Pelosi, Leader Schumer, Leader McCarthy, and Leader McConnell:

We the undersigned organizations are united both in our endorsement of the principles underlying the bicameral Agriculture Resilience Act (ARA; H.R. 2803/S. 1337) and the Climate Stewardship Act (CSA; H.R. 2534/S. 1072) and in our strong support for inclusion of key funding elements from those bills being included in the agriculture portion of the American Jobs Plan Act (AJPA) legislation.

More specifically, we endorse a robust AJPA investment in supporting agriculture to become more resilient and equitable and achieve the goal of negative emission farming. Such an investment, in our view, should be at least \$200 billion in size over the coming decade, should include farm bill conservation, research, renewable energy, energy efficiency, forestry, and regional food system and supply chain resilience programs, and should be in addition to the agriculture, forestry, and rural-related elements already contained in the President's American Jobs Plan.

We believe such an agriculture and climate package of at least \$200 billion would represent a fair share for agriculture, one that reflects both the urgent need for U.S. agriculture to adapt to a rapidly changing climate as well as the tremendous opportunity our farmers, ranchers, private forest owners, and rural small businesses have to contribute to climate change mitigation. It would enable at least a doubling of farm bill conservation program funding while also addressing other key underfunded areas in the urgent efforts needed to enhance agricultural resilience, improve soil health, sequester carbon in the soil, and reduce emissions from the agricultural sector.

We urge you to support such a robust agricultural investment as part of the infrastructure, climate and jobs legislation and encourage you to view the ARA and CSA as roadmaps for developing a comprehensive set of agricultural provisions for the AJPA. The two bills include proposed increases in funding, targeted to climate-smart agriculture, for a wide variety of highly successful existing programs.<sup>1</sup> These programs are oversubscribed and underfunded, seriously curtailing voluntary climate mitigation and adaptation opportunities for farms and ranches.

The bills also include significant funding for important new programs -- Assistance to States for Soil Health, Alternative Manure Management Program grants, long-term Grassland CRP enrollments, Soil Health Equipment Grants, and Meat and Poultry Processing Resilience grants -- recognizing gaps in current USDA programs that if implemented could significantly improve rural infrastructure and climate outcomes.

We believe all of these are worthy of inclusion in the AJPA as key building blocks for decarbonizing agriculture, building increased resilience, improving rural economies, and increasing job and farming opportunities.

Thank you for your ongoing bipartisan efforts to ensure that agriculture is part of the solution to climate change and part of the AJPA as it gets further developed by Congress. We hope you will support the inclusion of a comprehensive and robust farm conservation, agricultural research, renewable energy, forestry, and supply chain funding package as the legislation moves forward.
