#### **WIC Basics**

- Pregnant and postpartum people, infants, children under 5
- Receiving Medicaid, SNAP, TANF cash assistance or household income under 185% of poverty
- Science-based foods, nutrition education, breastfeeding support, referrals
- Specific type & quantity of foods plus cash-like benefit for fruit and vegetables
- Authorized under the Child Nutrition Act




# WIC Contributes to Positive Developmental and Health Outcomes

- Stronger connections to preventive health care
- Improved cognitive development

Note: Estimates for 2016-2020 differ from estimates for 2005-2015 because of changes to analytical methodology and are not directly comparable.



#### Share of eligible people participating in WIC



## Eligible Pregnant People, Toddlers Less Likely to Participate in WIC






## **WIC Funding**

- Discretionary—set through the annual appropriations process
- Bipartisan commitment since 1997 to full funding
- WIC is extremely cost-effective
- Current threats
  - Shutdown
  - Continuing resolution
  - Pending appropriations bills are inadequate
